This revision is intended to update the Access Management Manual.

Contents

This manual change results from the provisions of Senate Bill 1609, 80th Legislature, 2009. To emphasize some points about the manual change and related access activities:

- ◆ As indicated by legislative discussions, this manual change includes the reorganization of the manual's contents to consolidate access management practices into one document that will facilitate the ability of property owners to locate and understand the required procedures.
- ◆ The provisions of Senate Bill 1609, 80th Legislature, 2009, have been added, specifically including a revision to the appeals process.
- ◆ No revisions have been made to the minimum connection spacing criteria.
- ◆ Resolution of access issues at the local level is strongly encouraged.
